Non-Traditional Roles/ Supervision Requirements

The Section discussed the use of occupational therapy assistant credentials when working in non-traditional roles. The Section will draft a standard response regarding use of credential in non-traditional roles. The Section will also add this topic to the Board's future presentations.

Level I Supervision CE Rules

The Section reviewed other jurisdictions' rules regarding continuing education credit for supervision of Level I occupational therapy students. The Section will draft proposed language to allow continuing education credit for supervising Level I occupational therapy students.

Display of Wall Certificate

The Section discussed the display of wall certificates. The Section discussed removing the display requirements for the wall certificates. In the interim, the Section will draft a standard response on how to appropriately display the wall certificate and definitions for the terms "primary place of employment" and "conspicuous" as stated in section 4755.08 of Ohio Revised Code and rule 4755-3-02 (B) of the Ohio Administrative Code.
