The Common Sense Initiative was established by Executive Order 2011-01K and placed within the Office of the Lieutenant Governor. This rule outlines the roles and responsibilities of the individuals involved in occupational therapy care.

4755-7-08 – Code of ethical conduct

This rule establishes the occupational therapy code of ethical conduct that all licensees must follow.

4755-7-10 – Required credential to indicate licensure or student status

This rule identifies the appropriate credentials for licensees and students to use to indicate their status as a licensee or student.

The mission of the board is to ensure that consumers of occupational therapy services receive safe, competent, and adequate services from licensed practitioners. The rules in this package govern issues related to professional standards that, if followed, will help ensure safe practice.

6. How will the Agency measure the success of this regulation in terms of outputs and/or outcomes?

Success will be measured by having the rules written in plain language for clarity and by licensees following the standards of practice of the profession and not acting in a manner that will potential lead to disciplinary action for violation of the Practice Act.

The Board emailed stakeholders on November 14, 2014. Stakeholders were informed that comments were due to the Board by December 5. Stakeholders included licensees who are on the Board's listserv and individuals who follow the Board's Facebook and Twitter pages.

8. What input was provided by the stakeholders, and how did that input affect the draft regulation being proposed by the Agency?

The Board received a general comment regarding the rules in Chapter 4755-7. The comment asked the Board to carve out group mental health practice. Since the Board's rules apply to all practice settings, the Board did not feel it was appropriate to incorporate this change for a single practice setting.

9. What scientific data was used to develop the rule or the measurable outcomes of the rule? How does this data support the regulation being proposed?

This question does not apply to these proposed changes.

10. What alternative regulations (or specific provisions within the regulation) did the Agency consider, and why did it determine that these alternatives were not appropriate? If none, why didn't the Agency consider regulatory alternatives?

There were no alternative regulations that the agency considered since the roles and responsibilities of the individuals providing occupational therapy services must be followed by all licensees.

The Board's website contains information for licensees on the professional standards that licensees and other individuals must follow in the provision of occupational therapy services. The Board is not planning on making changes to these existing rules, so licensees are currently aware of the requirements. The laws and rules documents are posted on the Board's website.

Adverse Impact to Business

Licensed occupational therapists and occupational therapy assistants, student occupational therapists and student occupational therapy assistants, and unlicensed personnel.

Individuals violating the rules in this package could potentially face disciplinary action against their Ohio license.

Sanctions can range from a written reprimand or monetary fine to suspension or revocation of the Ohio license.

15. Why did the Agency determine that the regulatory intent justifies the adverse impact to the regulated business community?

The mission of the Board is public protection. The rules in this package help ensure that the consumers of occupational therapy services receive safe and competent services from the Board’s licensees.

Regulatory Flexibility

16. Does the regulation provide any exemptions or alternative means of compliance for small businesses? Please explain.

No. However someone violating the rules in this package will not automatically lead to disciplinary action being taken against the individual’s license.

17. How will the agency apply Ohio Revised Code section 119.14 (waiver of fines and penalties for paperwork violations and first-time offenders) into implementation of the regulation?

The provisions of R.C. 119.14 would be taken into account by the Board when determining if disciplinary action should be taken. The disciplinary guidelines followed by the Board

address first time offenses for paperwork violations. In most cases, those individuals would receive a non-disciplinary warning letter.
