Jennifer Wissinger reported that the Enforcement Review Panel continues to work on the FSBPT recommended disciplinary matrix.

Old Business

Update on JAM work and discussion of requirements

The Executive Director reported on the requirements for the development of the Jurisprudence Assessment Module (JAM). Tim McIntire moved that the Section move forward with the amendment to the NPTE agreement to accommodate the JAM. Lynn Busdeker seconded the motion. The motion carried.

New Business

Reinstatement applications – Laws and Rules or JAM

Tim McIntire moved that for PT and PTA licensure reinstatement, the Board will require the JAM instead of the law exam. Lynn Busdeker seconded. The motion carried. The Executive Director will file a rule change to implement.

PTA Foreign Education Review Tool

Ron Kleinman moved to adopt the FCCPT tool, PTA Tool 2, as the requirement to be used to evaluate the education of a foreign trained PTA. Lynn Busdeker seconded the motion. The motion carried.

TOEFL Score Requirements

Tim McIntire moved to raise the minimum TOEFL score for foreign trained applicants to either match or be higher than the scores required by FSBPT. The required TOEFL will be 24 for writing, 26 for speaking, 21 for listening, and 22 for reading. CJ Miller seconded the motion. The motion carried. The Executive Director will file a rule change to implement.

PT Compact Privileges

Lynn Busdeker moved that the Section will ask information about the PT Compact to check for discipline or privilege denial for licensure by endorsement, reinstatement, and renewal. Tim McIntire seconded the motion. The motion carried.

PT Section Retreat Items

The Section will hold the retreat on the July 25, 2019 after the regular scheduled meeting. The Section retreat topics are Disciplinary matrix, code of ethics, TOEFL Waiver, and documentation.




There being no further business and no objections. Jennifer Wissinger adjourned the meeting at 11:40 am.
