The affidavit contains the evidence and testimony upon which you will deliberate. Please take a few moments to review the evidence and testimony.

In lieu of a stenographic record being made, let the minutes reflect the original sworn affidavit and exhibits shall be kept as the official record of the proceedings in the aforementioned matter in the Board office.

I will now recognize Assistant Attorney General, LaTawnda Moore, for the purpose of providing a brief synopsis of the cases.

Ms. Moore reviewed case numbers PT-19-006 John Price, PT-19-004 Devinn Wahl, PT-LD-19-004 Myia King for the Board.

1. The Board had jurisdiction to conduct a hearing in this matter pursuant to *Goldman v. State Medical Board of Ohio*, 110 Ohio App. 3d 124; 673 N.E.2d 677 (1996).
2. Wahl documented or billed for services not provided for multiple patients on April 1 and April 27, 2019.
3. Wahl did not request a hearing on the aforementioned charge

In the matter of case number PT-19-004 Devinn Wahl, after review of the evidence the Board makes the following conclusions of law:

1. Wahl was properly served with the Notice of Opportunity of Hearing pursuant to R.C. 119.07.
2. R.C. 119.07 required Wahl to request a hearing within thirty days of the mailing of the Notice
3. Wahl's documenting or billing for services not provided in the course of her practice as a physical therapist assistant violates Ohio Rev. Code 4755.47(A)(5), (6), & (13), and Ohio Administrative Code 4755-27-05(B)(5)(i).

In the matter of for case number PT-LD-19-004 Myia King, after review of the evidence the Board makes the following findings of fact:

1. The Board had jurisdiction to conduct a hearing in this matter pursuant to *Goldman v. State Medical Board of Ohio*, 110 Ohio App. 3d 124; 673 N.E.2d 677 (1996).
2. On October 4, 2018, Ms. King submitted an application for a physical therapist assistant license by endorsement along with a verification of her license from the state of Virginia and a transcript indicating she holds a Master's Degree in physical therapy to the Ohio eLicense portal.
3. King did not request a hearing on the aforementioned charge.

In the matter of case number PT-LD-19-004 Myia King, after review of the evidence the Board makes the following conclusion of law:

1. Myia King has violated ORC Section 4755.47(A)28 and 4755.451(D) and OAC 4755-23-02(B).

In the matter of for case number PT-19-006 John Price, after review of the evidence the Board makes the following findings of fact:

1. The Board had jurisdiction to conduct a hearing in this matter pursuant to *Goldman v. State Medical Board of Ohio*, 110 Ohio App. 3d 124; 673 N.E.2d 677 (1996).
2. Mr. Price has been licensed as a PTA in Ohio since 2013. The Board received records from Mr. Price's employer indicating he had documented and billed for multiple treatments that had not occurred.
3. Price did not request a hearing on the aforementioned charge.

In the matter of case number PT-19-006 John Price, after review of the evidence the Board makes the following conclusion of law:

1. John Price has violated ORC 4755.47(A)(5), (6), (13), and OAC 4755-27-05(A)(3), (B)(1), (5)(i), and (B)(9).
2. The Section recommends a written reprimand, fine of \$500, and three specific ethics continuing education courses within 90 days.




