The individual named does not have the ability to present written or oral testimony today but may be present to hear the proceeding and outcome.

You have already received a sworn affidavit from the Board's Enforcement Division Supervisor, and the accompanying exhibits for the Goldman Proceeding in your Board packet. The affidavit contains the evidence and testimony upon which you will deliberate. Please take a few moments to review the evidence and testimony.

In lieu of a stenographic record being made, let the minutes reflect that the original sworn affidavit and exhibits shall be kept as the official record of the proceeding in the aforementioned matter in the Board office.

Assistant Attorney General, Emily Pelphrey provided a brief synopsis of the case. Tim McIntire requested a motion to admit the facts and exhibits outlined in the sworn affidavit in the aforementioned case into evidence. Mario Baker made a motion, second by Ron Kleinman. Motion passed

There being no further evidence to come before the Board, this proceeding is now closed at 9:53am. The procedural and jurisdictional matters having been satisfied, we will now continue with the proceeding by deliberation on the sworn affidavit and exhibits. Karen McIntyre made a motion to recess the meeting in order to go into private session for the purpose of quasi-judicial deliberation on **Jessica Gallimore, case number PT-20-042** and to reconvene the meeting after deliberations are complete. The Meeting reconvened at 10:42 AM

Linda Lowes read the Section's decision regarding the findings of fact, and conclusions of law in case number **PT-20-42** regarding **Jessica Gallimore** we find the following:

Miss Gallimore, while employed at the Center for rehabilitation and sports medicine of Highland District hospital in Hillsboro, Ohio as a Physical Therapy Assistant entered into a sexual relationship with her patient. The sexual relationship lasted on or about the month of Sept 2019 between Gallimore and said patient identified and this constitutes violation of Ohio Revised Code 4755.47 (a), (5), (11), 25a and 28 and Ohio Administrative code 4755-27-05 (A) (2), B5f, 7b and 8b.

Pursuant to Ohio Revised Code 4755.47A the Ohio Physical therapy Board will implement the following:

- 1) Suspend Ms. Gallimore's license for 6 months,
- 2) Require Ms. Gallimore to successfully complete the Probe Ethics training during this time period,
- 3) Pay a \$500 fine,
- 4) Ms. Gallimore is required to report this disciplinary action to new employers.

The Board also orders that any document that contains the patient's name or other possible identifying information be sealed to protect patient confidentiality.
